In compliance of UGMEB and Ethics & Medical Registration Board, National Medical Commission providing following Clarification on various issues relating to Foreign Medical Graduates (FMGs) :-

1. Students return to India during their final year and attend classes in online mode and return to their University/College abroad and compensated their online classes and subsequently completed their Final year in offline mode before start of internship.

As per guideline by NMC and other state Medical Council subject that applicant returned to be their respective University/College and compensated their study and completed Final Year in offline mode in that case applicant eligible to undergo One Year Internship in India per CMRI norms. Compensation certificate submitted by the FMG students to be verified form their University/College before issuing the Provisional/Permanent registration Certificate.

2. Regarding students return to India during their Pre-Final year and attend classes in online mode and return to abroad and compensated pre-Final year study and completed their Final year in offline mode.

As per guideline by NMC and other state Medical Council subject that applicant returned to their respective University/College and completed final year in totally offline mode, in that case applicant eligible to undergo One year internship in India as per CMRI norms.

3. Regarding those students who return to India due to COVID-19, Ukraine-Russia war and completed their pre final & final year in online mode from India Pre-Final year and final year.

As per guideline by NMC and other State Medical Councils that if applicant completed Pre-Final & final year in totally online mode from India, in that case applicant eligible to undergo two-year Clerkship & one-year internship in India as per CMRI norms.

4. The following self attested documents are require before issuing Permanent Registration to practice modern Medical/Allopathy in Rajasthan Medical Council :-

1. 12th passed certificate from CBSE/RBSE and other equivalent board.
2. Eligibility certificate from MCI/NMC, New Delhi.
3. MBBS passed Certificate/Degree.
4. Screening Test examination passed certificate issued by NMC.
5. Internship Completion Certificate (ICC)
6. In compliance of NMC (UGMEB) circular no. U.15024/10/2023-UGMEB-Part III/060880 Dt. 20th Dec. 2023, the following documents may also be required in addition before issuing Permanent Registration :-
 - a. Passport, All Visa documents providing evidence of stay in the Country for Medical Education, total no. of days of Classes along with stay in the country at each time, total no. of clinics, Practical Training in various disciplines topics taught and hours for each subject.
 - b. Certificate of passing for each year/semester.
 - c. Certificate Establishing License to practice modern medicine/allopathy in the Country of Graduation.
